

### Customer weed management

MI supports customers seeking to reduce and/or manage weeds on the channel banks adjacent to their properties. Where safe to do so, effective mechanical and/or chemical controls can improve both farm and irrgation operations and access.

This fact sheet outlines the options which can be undertaken by our customers.

#### Note

- No aerial spraying is approved on MI lands under this Fact Sheet
- Weed management is limited to channel banks adjacent to your farm boundary only, unless otherwise agreed in writing by MI. is a bullet point running over a couple of lines, keeping the same line spacing as the body text.

### Chemical use - what's allowed/suitable?

MI's Environmental Protection Licence (EPL) has strict limits on the following chemicals in any water being discharged out of the MIA. These limits also apply to any drainage waters leaving customer properties through their approved drainage inlets.

MI's EPL requires all chemical use on our lands to be recorded promptly and available for inspection by the EPA.

### Chemicals not approved

To comply with our EPL, MI cannot accept the use of any of these chemicals on our lands:

- Atrazine Gesaprim
- Chlorpyrifos Lorsban
- Diazinon Dizzy, Diazol, Pennside [insecticides only]
- Diuron Diuron, Diurex
- Malathion Fyfanon, Maldison, Hy-Mal
- Metolachlor Dual Gold, Metalochlor 720 or 960, Metolamax Gold, Boxer Gold, Primextra Gold
- Molinate Sirion, Nufarm Ordram
- · Simazine Simast, Simakey, Gesatop
- Thiobencarb Nasi, Conquest Jupiter or Pluto or Saturn
- Trifluralin Treflan, Triflon, Trampoline, Trilogy, Tri-F, Flural, Triflur

Please note that trade names are not exclusive to those listed above.

#### Chemical use considerations

Chemical use on MI channel banks is subject to the following constraints:

- Application by an AQF3 or higher certified operator only
- Handled and applied on label, including consideration of nearby sensitive crops/ areas.
- Do not use chemicals with withholding periods and/or that need to retain tail water on site.
- Not applied within one metre of the edge of any drain/ channel/ waterway, regardless of whether water is present.
- Chemical use and other relevant information are recorded within 48 hours of application via the MI website.
- Records must be available for inspection at any time by MI or FPA.
- Note: MI consider the on-label use of glyphosate, Oxyfluorfen in combination with glyphosate and Valor to be low risk if used with sound agronomic advice.

## Record chemical use via MI's website

- Use the customer chemical records form via MI's website.
- Within 48hrs.
- Include all relevant details including rates, date and time of spraying, wind direction, wind speed,
- temperature and all other information as required by law.



# Acceptable activities on MI land by adjacent landholders

Mechanical activities or other non-chemical approaches for weed management which may or may not be acceptable are outlined below:

#### Acceptable activities

- · slashing and/or mowing
- light grading
- rubbish removal

#### Activities which are not acceptable:

- storage of fill, farm equipment, or other non-MI goods, including chemical containers
- · removal of any soil or fill material
- removal of, or damage to, any native vegetation
- removal or relocation of any MI equipment or assets
- burning without prior approval

### Please report Weeds of National Significance or State

Weeds of National Significance (WONS) are the worst weeds in Australia based on their invasiveness, potential for spread, and economic and environmental impacts. Key WONS known to occur in the MIA include: Alligator weed, Sagittaria, Willows, Silverleaf nightshade, African boxthorn, Boneseed, Blackberry, Prickly pear, Athel pine, Bridal creeper and Lantana. WONS and priority weeds are on the WeedWise website.

Please report any WONS or priority weeds on MI lands to MI via phone or email so we can look at the correct management and regulatory reporting.
